DAWN'S COMMUNITY ADVOCACY PROGRAM INCLUDES INDIVIDUAL CASE MANAGEMENT, LEGAL ADVOCACY, MOBILE ADVOCACY, EDUCATION AND OUTREACH, AND 24 HOURS CRISIS LINE. WE PROVIDED 10,553 CASE MANAGEMENT SERVICE HOURS, SERVED 1,733 CLIENTS IN THE COMMUNITY ADVOCACY PROGRAM, PROVIDED 125 WITH SUPPORT GROUPS, AND ANSWERED 4,653 CRISIS CALLS. ADDITIONALLY, DAWN CONDUCTED 18 24-HOUR DOMESTIC VIOLENCE ADVOCACY TRAINING. DAWN OFFERS SHORT-TERM, ONE-ON-ONE MENTAL HEALTH SUPPORT FOR SURVIVORS OF DOMESTIC VIOLENCE. OUR ON-SITE THERAPIST UNDERSTANDS THE DYNAMICS OF ABUSE AND THE IMPACTS ON SURVIVORS, AND PARTNERS WITH ADVOCATES TO GET CLIENTS THE SUPPORT SERVICES THEY NEED. WE CONDUCTED 10 TRAINING SESSIONS.
